INTERNATIONAL MAILS

Treatment of "Paquebot" Mail at Post Offices

It has been brought to the attention of the Department that a need exists for a uniform practice in the treatment by postmasters of "paquebot" correspondence (mail bearing foreign postage and received from vessels outside of regular dispatches).

The Universal Postal Union Convention provides for the acceptance at post offices under certain conditions of correspondence bearing foreign postage, if it has originated on board a vessel while on the high seas or in a foreign port. In order to be accepted as "paquebot" mail, such correspondence must be delivered to the post office at the port of arrival of the vessel in the United States. The delivery is made by an officer or representative of the steamship company, who brings the correspondence to the post office with a statement (written or oral) by which the postmaster (or his representative) is satisfied that the correspondence originated on the vessel under the prescribed conditions. If the foreign postage stamps have not already been canceled by a postal agent or officer on board the vessel, they are then canceled by the United States post office with a "paquebot" postmark or with the regular postmark; in the latter case the word "Paquebot" is placed on the envelope with ink or with a rubber stamp. No further payment of postage is required, assuming that the article bears postage as indicated below.

A "paquebot" letter, if mailed on the high seas, must be prepaid by means of the postage stamps and according to the postage rates of the foreign country which owns or maintains the vessel on which it was mailed. If mailed in a foreign port, it must be prepaid by means of the stamps and according to the postage rates of the country where the port is located.

An article mailed on board a vessel of United States registry on the high seas, or on board *any* vessel in a United States port, must be prepaid with United States postage. Such articles when brought to a United States post office are not treated as "paquebot" letters, but as regular domestic mail.

The following are examples of articles not entitled to receive "paquebot" markings at United States post offices:

Articles not bearing valid postage of a foreign country as indicated above.

Articles mailed in a letter box or letter drop.

Articles mailed at inland post offices.

Articles originating on board a vessel of foreign registry during its stay at a United States port.

Articles originating on board a vessel of United States registry on the high seas or in a United States port.

Numerous and varied irregularities have resulted from the furnishing, by certain collectors of "paquebot" covers, of covering envelopes to be used by officers of vessels in conveying philatelic covers from a vessel to the post office at the port of arrival, or for mailing them to another post office to receive "paquebot" markings. Sometimes these covering envelopes bear such endorsements as "Free," "No further postage required," or "Paquebot mail." Such articles are not entitled to free postage. "Paquebot" articles are not to be postmarked at a post office other than that of the port of arrival of the conveying vessel.

AIR POSTAL TRANSPORT

A. M. 55 and A. M. 75

Effective on or about March 15, 1948, air-mail service will be inaugurated on extensions of route A. M. 55 from Bristol, Tenn.-Va., to Atlanta, Ga., via Asheville, N. C., and from Birmingham, Ala., to New Orleans, La., via Mobile, Ala.; and effective on or about March 4, 1948, air-mail service will be inaugurated at Leesburg and Perry, Fla., on route A. M. 75.

No official cachet for first-flight covers will be authorized for Bristol, Tenn.-Va., Atlanta, Ga., Air Mail Field, Atlanta, Asheville, N. C., Birmingham, Ala., Air Mail Field, Birmingham, Mobile, Ala., New Orleans, La., and Air Mail Field, New Orleans, as cachets have previously been furnished for air-mail service at these points. However, souvenir covers received by the postmasters at the above-named offices, and by the district superintendent, District No. 1, Railway Mail Service, Atlanta, Ga., for Air Mail Field, Atlanta; district superintendent, District No. 4, Railway Mail Service, Birmingham, Ala., for Air Mail Field, Birmingham; and the district superintendent, District No. 1, Railway Mail Service, New Orleans, La., for Air Mail Field, New Orleans, will be dispatched to first flights, if practicable.

Special cachets will be provided for Leesburg and Perry, Fla., and the usual treatment of philatelic mail will be authorized.

First flight air-mail covers sent to the postmasters at Leesburg and Perry, Fla., should be accompanied by a letter authorizing the holding of the covers for the first flight and requesting the application of the cachet. Space approximately $2\frac{1}{2}$ by $2\frac{1}{2}$ inches to the left on the address side of all covers is required for the cachet.

At request of collectors, covers receiving cachets will be given directional service to a terminal or junction point designated by the regional superintendent, Air Postal Transport, and served by the first flight in each direction, and will there be backstamped and dispatched onward to destination.

INSTRUCTIONS OF FOURTH ASSISTANT POSTMASTER GENERAL

TRUCK DISPLAY OF POSTER "RED CROSS"

Postmasters at offices having Government-owned mail trucks will receive a supply of Red Cross posters.

The display of Red Cross posters on Government-owned mail trucks during the month of March 1948 is authorized.

FRAUD ORDER NOTICE (TEMPORARY RESTRAINING ORDER) Al Williams et al.

Should a covering envelope which has obviously been supplied by a collector be received at a post office without explanation from a representative of the steamship company, it should be opened. However, the philatelic cover, or covers, enclosed therein should not be postmarked, but should be sent to the Deputy Second Assistant Postmaster General, International Postal Service, with explanation of the circumstances, for appropriate disposal.

Postmasters at port post offices may obtain postmarking stamps containing the word "paquebot" by requisition, if the volume of such mail received justified their use.
